Limited lifetime warranty: Mila International, Inc. will, at its election, within the terms and conditions set forth in this warranty, replace or repair, without charge, any stainless steel sink supplied by Mila International, Inc. that is proven to have a manufacturing defect with an equivalent replacement. In the event of a warranty claim, proof of purchase will be required – save all sales receipts, and do not disregard original packaging. When filing a claim, please provide a copy of your purchase receipt, your product's model number, a brief description of the problem, as well as your contact information. Mila International, Inc. reserves the right to inspect the defective product prior to replacement.
